Where do our contribution go?, using A.A.'s Literature in carrying the message. To.. **How** are we communicating our experience, strength and hope?

Our DCM Sooz B was on that panel, She did an outstanding job delivering her representation to the group.

We had dinner then got to listen to past Delegates. We had dessert, then Part 1 of GSR sharing about "What are the ways your group fosters awareness in practicing our twelve traditions in a group setting" Groups from all over our area 72 went up to the mike and described how their group worked with the question at hand. It was interesting to hear all the stuff these groups did.

**Saturday:** opened with the serenity Prayer, the reading of the 12 traditions & 12 concepts.

Then we got down to business on the Motions to be voted on.

Practical experience shows that nothing will so much insure immunity from drinking as intensive work with other alcoholics, it works when other activities fail. this is our Twelfth Suggestion: Carry this message to other alcoholics! You can help when no one else can. You can secure their confidence when others fail. Remember they are very ill. Life will take on new meaning. To watch people recover. To see them help others, to watch loneliness vanish, to see a fellowship grow up about you, to have a host of friends— This is an experience you must not miss.

#### 12th Concept:

The conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principal; that it place non of it's members in a position of unqualified authority over others; that it reach all important decisions by a discussion, vote, and whenever possible, by substantial unanimity; that it's actions never be personally punitiven or an incitement to public controversy; that it never performs acts of government, and that, like the society it serves, it will always remain democratic in thought and action

# Friends in every port

By the grace of God, I was sober for 21 years in the Navy until I retired from service. It was a career I would have never had without AA. One of the blessings I received was attending AA meetings all over the world. But there's one experience that has stuck with me over the years.

We were anchored in Hong Kong harbor. It was an early morning, and I was irritated for no good reason. I was tired, but we sailors are always tired. The city smelled bad, and there were too many people around. It was humid, the sun was too bright and my feet hurt. I was starting to feel sorry for myself. A lot of bad thoughts were going on between my ears.

But I had a goal. There was a 1 P.M. AA meeting up the hill from the ship. When I got there, I was sweating and miserable, with the mess and not a message. There were about eight members in the meeting room. I really don't remember much except that I was disappointed that they had instant coffee. One guy chatted with me outside about the upcoming turnover of Hong Kong to mainland China. A woman told me about another AA meeting. I traded an American cigarette for a British one with a young man. Soon I started to feel like I belonged to these alcoholics. They all went off to their jobs and I was alone again on the sidewalk—but now I wasn't lonely anymore. My thinking was different; the world felt different. Instead of the city, I smelled flowers. I was able to accept the humidity. Even the people seemed different. They seemed excited, people from all around the world, all God's children. I got excited to take the train up to Victoria's Peak and see the view. It was a spiritual experience.

I know that God is in our AA meeting room, but is that enough? Can I join in God's world only in a room of drunks? The people in the streets of Hong Kong didn't change, the weather didn't change—I did. I allowed myself to be in God's world. I saw that I needed something bigger beyond that group. God was not only in our AA room, but also in those strangers outside of the rooms. It was time for me to stop limiting God. I used to live in the world and visit AA—now I live in AA and visit the world.

Back then I had many more years of travel ahead of me. When I was sent to locations where there weren't any AA meetings, I learned to connect with people in other spiritual beliefs. I needed to find God wherever I was. I now have 34 years of sobriety and I don't travel much anymore since I've retired from the Navy. I've had the same homegroup since 2014. It's been a big adjustment learning to live in one place. Occasionally I'll get an itch to move somewhere different, but that feeling passes. However, if I should move, I know there will be an AA meeting there. And if not, God will be.
